

# EURES Targeted Mobility Scheme

Fostering job mobility in Europe

## THE PROJECT

Funded by the European Commission under the EaSI strand of the ESF+, the EURES Targeted Mobility Scheme (TMS) is designed to promote and support job mobility projects taking place within the territory of the EU Member States, Iceland and Norway. To achieve this mission, EURES TMS offers a wide range of free services and financial support measures which are available to both employers and jobseekers.

In particular:

- it supports **jobseekers** in finding work, traineeship or apprenticeship opportunities in a European country other than the country of residence
- it helps **employers** throughout the process of selecting and recruiting candidates for their vacancies

## EMPLOYERS

### Who can participate

**All businesses or organisations** which are legally established in the EU Member States or the EFTA/EEA countries in accordance with the EEA Agreement (Iceland and Norway) can participate, **regardless of the economic sector in which they operate.**

**SMEs** are the main target business group and can benefit from financial support measures offered by the EURES TMS.

Placement with European institutions and bodies and other international policy, economic, social and scientific organisations, supra-national regulatory bodies and their agencies **is ineligible.**

## JOBSEEKERS

### Who can participate

**All candidates wishing to find a job, traineeship or apprenticeship** in a EU Member State, Iceland or Norway other than their country of residence, who are:

1. aged at least **18**
2. **nationals** of any of the EU Member States and the EFTA/EEA countries in accordance with the EEA agreement (Iceland and Norway) or legally resident in a EU Member State, Iceland or Norway
3. third country nationals holder of an EC residence permit (Directive 2003/109)

All candidates fulfilling these criteria are eligible, **irrespective of their level of qualification, work/training experience or economic and social background.**
